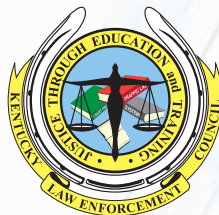




CDP INFORMATIONAL GUIDE



INTRODUCTION

Since 2002, the Kentucky Law Enforcement Council (KLEC) has administered a Career Development Program (CDP) for Kentucky's law enforcement officers and public safety dispatchers. Kentucky is the eighth comprehensive, statewide career development program for law enforcement in the nation, and will offer the most comprehensive program for public safety dispatchers.

After eighteen years, the CDP is being updated to include new training tracks, new career tracks for Court Security Officers, Sheriff's and Deputy Sheriffs. Deputy Sheriffs will now be categorized as peace officers for their career tracks.

The Career Development Program provides structure to the training process through career tracking. Each track has steps of achievement which consist of required levels of training, education and experience. The Career Development Program is regulated by 503 KAR 1:170. *Welcome to the Kentucky Law Enforcement Council Career Development Program.*

USE OF THE MATRIX

Career step training, education and full time experience are represented by matrices, which are included in this booklet for each career track.

The illustration below is the matrix for the Intermediate Law Enforcement Officer Career Track. This track is directed towards law enforcement officers that wish to enhance their skills in the area of patrol. In order to achieve this step, the applicant must hold the basic Peace Officer Professional Standards Certificate, complete 160 hours of in-service with a focus on technical and human skill development and possess the required education and full time experience.

INTERMEDIATE LAW ENFORCEMENT OFFICER

Training: POPS Certificate + 160 hours of in-service training
 60% (96 hours) must be in technical skill development
 40% (64 hours) must be in human skill development
 Education must be satisfied with either a college degree or training points*

Using the above matrix as an example, suppose an applicant with 5 years of full-time law enforcement experience completed the in-service training requirements for the Intermediate Officer track. The officer would need either a college degree or a minimum of 80 educational training points before an Intermediate Law Enforcement Officer Certificate could be awarded. Training points are awarded at one point for every 15 hours of KLEC approved training, including basic training. College hours are awarded at 1 point per 1 semester hour.

In this example, this officer attended a 640-hour basic training academy and 160 hours of in-service classes for a total of 800 hours of training. This equates to 53 training points, $800/15=53$, meaning the officer needs only 27 additional training points or 27 semester hours of college to fulfill this certificate. Training points are not needed if the applicant has a college degree.

WHY PARTICIPATE IN THE CAREER DEVELOPMENT PROGRAM?

The Career Development Program adds value to training. This is accomplished by focusing law enforcement officers and public safety dispatchers on training that is most relevant to their current or future career paths. Participants that wish to enter management would use the management track to focus on courses and education that develop a well-rounded understanding of management principles. In essence, program participation ensures that training and educational efforts are aligned with participant career objectives. Participants report increased salaries with the Career Development Program. Participants become more effective and valuable as they advance through the program, causing salaries and benefits to increase. The Career Development Program is a great tool to recruit and retain your employees.

Participants will be awarded Certificates of Achievement and uniform pins by the Kentucky Law Enforcement Council as they complete career steps. Furthermore, the Council will acknowledge participants through media releases, the Kentucky Law Enforcement Magazine and via the KLEC web site.
