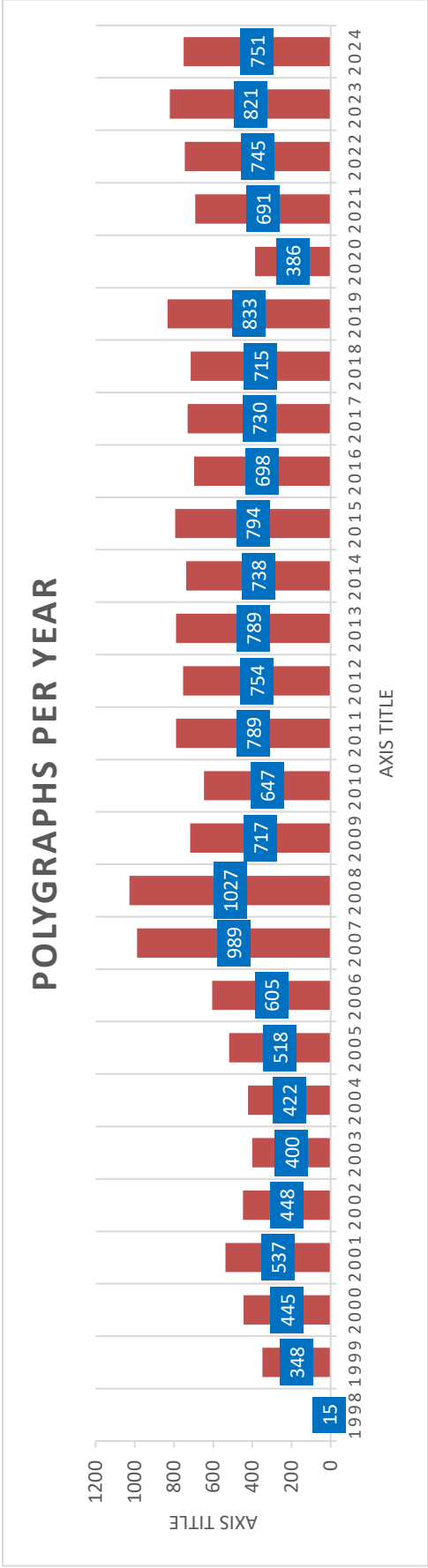
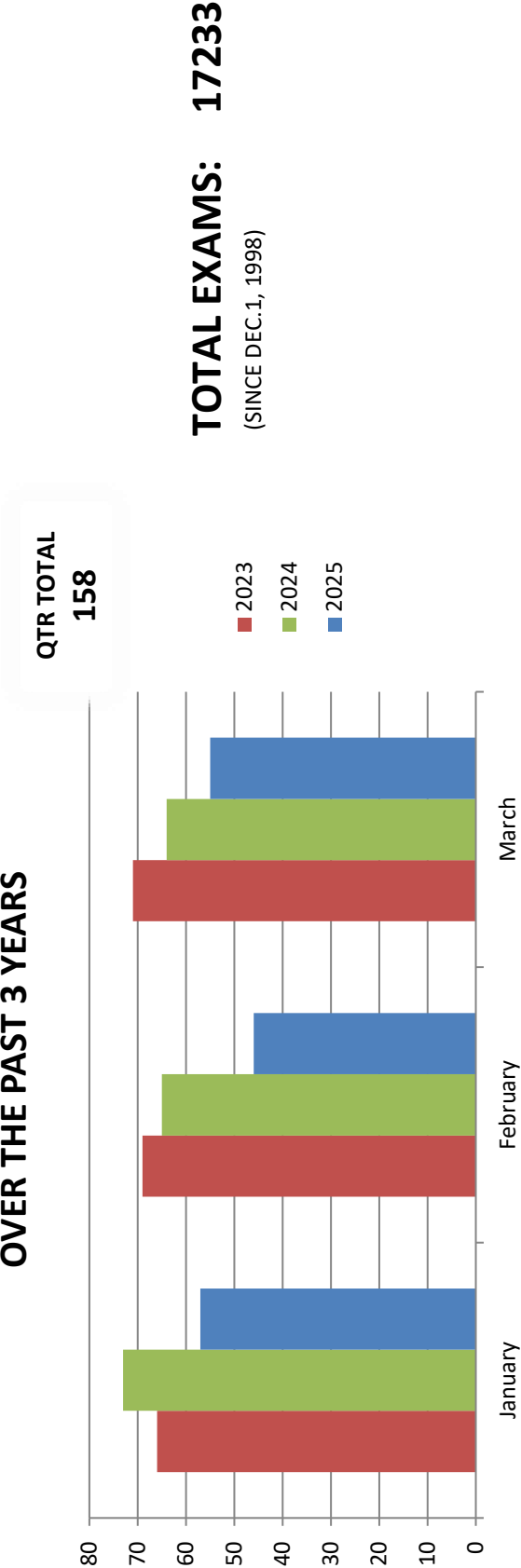

INVESTIGATION: Horse Cave PD Case 25-3 Investigator: Larry Oliver	KLEC Director Rob Ratliff was provided a copy of the investigation regarding the failure of Horse Cave PD to qualify with their weapons in 2024. The investigation revealed the following: the agency did not qualify in 2024; they submitted a signed Form 68-3 to KLEC (Deanna Boling) for 2024 indicating their officers qualified; the range officer entered all the names of their 8-man department in LETRS indicating they qualified. Form 68-3 was signed by Firearms Instructor Derick Murphy & Chief Heather Childress. Chief Childress initially stated the agency qualified in 2024 but ultimately admitted they did not. Agency was audited again.
