#### **Additional Discussion:**

Dr. Currie - Delta 8 is legal, Delta 9 is not legal and many of the THC products contain both products. Any time those packages have a milligram amount listed, we really have no idea what is in that product or how much because they are not regulated. Lack of regulation of those products needs to be explored as a potential recommendation.

Dr. Anderson – Even though Delta 9 is not legal, they are available in smoke shops in Kentucky. They are marketed and sold which creates consumer confusion.

The panel needs to develop a more concrete definition for serial relationships and/or lack of protective parenting capacity. Members agreed to form a subcommittee to investigate how other jurisdictions, including the legal and medical fields define the terms.

Potential recommendation – Birth hospitals and central intake need additional educational around the importance of a newborn child receiving vitamin K at birth. If a parent refuses the medication, it should be reported to CPS as medical neglect.

Dr. Melissa Currie made a motion to adjourn, which was seconded by Dr. Henrietta Bada. With no further discussion we will stand adjourned. Thank you.
